Principal's Message

Our mission statement, "The Evergreen community respectfully nurtures and engages each student in realistic, meaningful, and collaborative learning," genuinely reflects the purpose and commitment of our school. The Evergreen community shares our vision of setting high expectations as we consistently work to achieve academic success for all students, promote a positive school climate, and maintain an emotionally, intellectually, socially, and physically safe school environment.

Evergreen offers its students a challenging and comprehensive program at every grade level and in every classroom. We are proud of the fact that our students continue to meet high expectations and grade level standards.

Community & School Profile

Evergreen School District, located in the city of San Jose, is comprised of fifteen elementary schools and three middle schools. Once a small farming city, San Jose became a magnet for suburban newcomers between the 1960s and the 1990s, and is now the third largest city in California. The city is located in Silicon Valley, at the southern end of the San Francisco Bay Area, and is home to more than 973,000 residents.

Evergreen Elementary School is located in the southeast quadrant of the district's borders. The school provides a family-oriented, nurturing, and safe place for students to learn, grow, and develop intellectually. Teachers, staff, and administrators continue to act on the principle that students come first. During the current school year, Evergreen School serves 806 students in grades transitional kindergarten through six on a traditional calendar schedule. Thirty-seven percent of our student population is Asian Indian. Twenty-one percent is Vietnamese and Sixteen percent is Chinese. The remaining twenty-five percent of our student population includes students of the following cultures: Filipino, Indian/Alaskan, Japanese, Korean, Laotian, Cambodian, and Tahitian.

Discipline & Climate for Learning

Students at Evergreen Elementary School are guided by specific rules and classroom expectations that promote respect, cooperation, courtesy and acceptance of others. The goal of the school's discipline program is to provide students with opportunities to learn self-discipline through a system of consistent rewards and consequences for their behavior.

The district has adopted the "Discipline with Dignity" program, which all schools utilize. Additionally, a partnership with Project Cornerstone has been forged, which promotes research-based developmental assets as a guiding framework for the support and healthy development of all children. The school supplements the district's discipline guidelines with the Expect Respect program.

Parents and students are informed of school rules and discipline policies at the beginning of the school year through the Parent-Student Handbook. Ongoing school-to-home communication is facilitated through weekly newsletters, Back-to-School Night, Open House, parent-teacher conferences, e-mails, Friday Folders, and the school website.

About the SARC

Every school in California is required by state law to publish a School Accountability Report Card (SARC), by February 1 of each year. The SARC contains information about the condition and performance of each California public school. Under the Local Control Funding Formula (LCFF) all local educational agencies (LEAs) are required to prepare a Local Control Accountability Plan (LCAP), which describes how they intend to meet annual school-specific goals for all pupils, with specific activities to address state and local priorities. Quality, Currency, Availability of Textbooks and Instructional Materials (School Year 2014-15)

Evergreen School District held a Public Hearing on October 9, 2014, and determined that each school within the district has sufficient and good quality textbooks and instructional materials pursuant to the settlement of Williams vs. the State of California.

All students, including English Learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. All textbooks and instructional materials used within the district must be aligned with the California State Content Standards and Frameworks, with final approval by the Board of Trustees. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. The table displays information collected in September 2014 about the quality, currency, and availability of the standards-aligned textbooks and other instructional materials used at the school. The district does not have a formal textbook adoption for Health or for Visual and Performing Arts.

School Facility Conditions and Planned Improvements (Most Recent Year)

Evergreen Elementary School was originally constructed in 1955. School facilities are currently comprised of 19 permanent classrooms, 13 portable classrooms, psychologist/speech office, day care room, computer lab, library, cafeteria/multipurpose room, kitchen, staff lounge, conference room, stage, and two playgrounds.

The district passed a facilities bond measure in 2006 that will allow for future modernization. As a result of this bond, Evergreen Elementary School has recently completed major construction. Nine new classrooms have been added, the new parking lot has been completed, and the new multi-purpose room serves hot lunches to our students on a daily basis as well as provides additional space for extra curricular activities. In 2013 the multi-use/library conversion was completed resulting in an enhanced library and computer lab for student and staff use. The chart displays the results of the most recent facilities inspection.

Cleaning Process:

Evergreen Elementary School provides a safe and clean environment for students, staff, and volunteers. The district has adopted cleaning standards for all schools in the district. Basic cleaning operations are performed on a daily basis throughout the school year with emphasis on classrooms and restrooms. A joint effort between students and staff helps keep the campus clean and litter-free. The principal works daily with the school’s custodial staff to develop sanitation schedules that ensure a clean, safe, and functional learning environment.

Maintenance & Repair:

A scheduled maintenance program is administered by Evergreen Elementary School’s custodial staff on a regular basis, with heavy maintenance functions occurring during vacation periods. Additionally, a scheduled maintenance program is administered by the district to ensure that school grounds and facilities remain in excellent repair. A work order process is used when issues arise that require immediate attention. Emergency repairs are given the highest priority; repair requests are completed efficiently and in the order in which they are received.

Deferred Maintenance Budget:

The State School Deferred Maintenance Program provides state matching funds on a dollar-for-dollar basis, to assist school districts with expenditures for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. In the Budget Act of July 2009, the State Legislature provided school districts with flexibility in using these funds to meet general fund needs. In an effort to mitigate the effects of declining state revenues, the Evergreen School District has taken advantage of this flexibility. The district will utilize bond funds and other appropriate sources to ensure its facilities are clean, safe and in good repair.

Opportunities for Parental Involvement

Evergreen School has an active and supportive Parent/Teacher Association that coordinates many parent and student activities for the school.

Parents serve as School Site Council members and English Language Advisory Committee members, parent volunteers, classroom aides, field trip chaperones, noon duty supervisors, and at-home teacher helpers. Parents also provide clerical help for the teachers and sponsor staff recognition activities.

The PTA sponsors family nights throughout the school year, including Family International Day and Science Night. Parents may also participate in the Project Cornerstone-sponsored ABC Book Program. This particular aspect of the program allows parents to implement a lesson plan that uses literacy to address student issues and promote values.

The school also receives support from numerous local businesses and community organizations. Support and/or donations from Target, Box Tops For Education, Yahoo, Evergreen United, and Evergreen Valley High School have greatly added to the quality of instruction and overall school environment.

School Safety Plan

The safety of students and staff is a primary concern at Evergreen Elementary School. Students are supervised before school, during recess, and after school by teachers and principal. Lunch supervision is provided by noon-duties. All visitors to the campus must sign in at the office and wear a visitor's pass at all times during their stay on school grounds. There is also a designated area for student drop-off and pick-up at the front of the school.

The School Site Safety Plan was last reviewed and updated in Winter 2014. All revisions to the plan are immediately communicated to classified and certificated staff.

- Key elements of the Safety Plan focuses on the following:
 - School rules and procedures
 - Sexual harassment policy
 - Child abuse reporting procedures
 - School-wide dress code
 - Policies related to suspensions and expulsions
 - Disaster procedures/routines and emergency drills
 - Safe ingress and egress of pupils, parents and school employees

The school is in compliance with the laws, rules, and regulations pertaining to hazardous materials and safe earthquake standards. The school's disaster preparedness plan includes steps for ensuring students and staff safety during a disaster. Fire, disaster, and lock down are conducted on a rotating basis throughout the school year.
