School Facility Conditions and Planned Improvements (Most Recent Year)

Valencia Elementary opened in 1969 and was modernized during the 2001–2002 school year. We upgraded student and staff restrooms, installed new carpeting, and reconfigured the staff lounge and workroom. The site has permanent and portable structures configured to provide traditional classroom settings, a multipurpose room, a library and media center, a food-service area, administrative offices, and extensive athletic fields. PTA support has enabled us to purchase a new shade cover for the lunch area and new playground equipment. Measure B funds provided an additional shade structure for our kindergarten play area; upgraded fields and perimeter fencing, the new multiuse building, and portable buildings; and improved drainage as well as entrances and exits for the public and emergency personnel.

More facts about the condition of our school buildings are available in an online supplement to this report called for by the Williams legislation of 2004. What you will find is an assessment of more than a dozen aspects of our buildings: their structural integrity, electrical systems, heating and ventilation systems, and more. The important purpose of this assessment is to determine if our buildings and grounds are safe and in good repair. If anything needs to be repaired, this assessment identifies it and targets a date by which we commit to make those repairs. The guidelines for this assessment were written by the Office of Public School Construction (OPSC) and were brought about by the Williams legislation. You can look at the six-page Facilities Inspection Tool used for the assessment on the Web site of the OPSC.

Parent Teacher Association (PTA) members contribute volunteer hours working in classrooms, participating on field trips with students, and helping to organize extra-curricular activities. The group raises money to support the science and engineering programs, the art program, the computer lab and 1:1 Chromebook programs, the library collection and health and safety supplies. Our School Site Council (SSC) is the primary governing body that approves the Single Plan for Student Achievement. Our English Language Advisory Committee (ELAC) also meets to address the educational needs and issues related to our second language learners and families.
