Principal's Message

Mountain Valley Academy is a unique place for learning. Our alternative school incorporates a non-threatening flexible environment that fosters self-motivation and responsibility for students' own learning. Parents are considered partners in their child's education, working actively with teachers for the good of the student. The transitional kindergarten through 12th grade program provides opportunities for students of all grade levels to interact providing positive role models for our younger students. Our campus offers an industry-standard computer lab, with additional portable electronic devices available in all classrooms. Our library collection is reflective of the breadth of student needs on our campus.

Mountain Valley Academy is a free public school of choice, meaning that students throughout the district may enroll in our programs. The campus offers two alternative schools: Ramona Community Montessori School, a TK-6 instructional program based on the principles of Dr. Maria Montessori, and Mountain Valley Academy, a TK-12 independent study college model where students attend class two to five days a week, completing research based projects at home. Mountain Valley Academy High School program is WASC accredited and has been recognized as one of the top 8% high schools in the country by US News and World Report, as well as recognition as a California Gold Ribbon School. Our elementary programs earned California Distinguished School recognition in 2014. Our campus also serves as a satellite campus for Palomar College, allowing students to easily access college courses for dual credit.

The teaching and support staff of Mountain Valley Academy provide a unique, individualized alternative education for students by offering a choice in learning methodology, curriculum, resources, and experiences from a caring, student-centered, knowledgeable staff. We implement site-based decision making so students can excel academically, technologically, and socially to become productive citizens in society and sustain a life-long love of learning.

School Safety Plan

Mountain Valley Academy recognizes that students and staff have the right to a safe and secure campus where they are free from physical and psychological harm. The school is fully committed to maximizing school safety and creating a positive learning environment that sets high expectations for student conduct, responsible behavior and respect for others. Mountain Valley Academy maintains a comprehensive safety plan that identifies major safety concerns including violence prevention strategies and actions to be taken in the event of a crisis.

Campus Safety Officers monitor students at lunch and recess (TK-8), and Campus Security supervises our high school students outside of classrooms. These personnel also monitor gates and campus access areas. Parents and other visitors are directed to the main office to sign in/out and obtain visitor badges. All campus safety/security staff, custodians, and office personnel have two-way radios to ensure immediate communication.

The School Safety Plan includes specific procedures for evacuation, lockdowns, earthquake, intruder, hazardous materials, and dangerous situations on/near campus. All students participate regularly in drills for all of those situations. The Safety Plan includes details for Command Post and all emergency teams. The Safety Plan is reviewed and revised each Fall by our School Site Council and staff.

Types of Services Funded

We believe all students can learn, and we recognize that all students learn and retain information in different ways. For students with differing learning styles or disabilities, RUSD has a wide variety of intervention programs. The District provides regular education, categorical programs and additional educational opportunities designed to help all students meet or exceed grade-level standards and to prevent students from falling behind. Federal categorical and additional educational opportunities are funded through the Elementary and Secondary Education Act, which was reauthorized in 2015 as the Every Students Succeeds Act. These programs include, Title I (English Language Arts and Mathematics support); Title II (Improving Teacher Quality); Title III (support for English Language Acquisition). State funding provides supplemental dollars so the District can provide additional service to unduplicated count students, including foster youth, English language learners, homeless youth, and students of low income families. RUSD offers a wide variety of alternative education programs and settings, including the Ramona Community campus which houses the Ramona Community Montessori School (TK-6) and Mt. Valley Academy (TK-12 Independent Study); Future Bound (7-12 off campus Independent Study); and Montecito Continuation High School (9-12).
