School Facility Conditions and Planned Improvements (Most Recent Year)

The physical plant was open for use in August 2006 and has been in use for the past four years. The adjacent magnet school (Valenzuela) merged with Maxine Hong Kingston School. This campus is a Preschool through 8th grade campus, serving approximately 1000 students within our zone boundaries. We are located within Zone H, which also serves three other local schools within our district.

Maxine Hong Kingston/Valenzuela School has 4 buildings in Magnet program, three main classroom buildings, a multipurpose room, a music room, a library, media center, and an administration building. Two Orthopedically Handicapped (OH) classes are housed in the E Building. There are no portable classrooms or structures on site. There are three main playground areas, and access to the park for field activities.

In January 2009, a classroom in the C Building was renovated into a licensed preschool room. State Preschool was offered in the morning for students whose families qualified under income guidelines. In August 2013, the preschool room was moved to Room 1 in Magnet program building.

District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. MainSaver, the district's work order process, is used to ensure efficient service and that emergency repairs are given the highest priority.

A scheduled maintenance program is administered by the district to ensure that all classrooms, restrooms, and facilities are well-maintained and in good repair. The principal works regularly with the custodial staff to develop cleaning schedules to ensure a clean and safe school. During the breaks, custodial cleaning plans are scheduled between the Head Custodian and the Principal to ensure site priorities are addressed and maintained.

The following projects are scheduled to be completed in 2013-2014. A security buzzer is being installed in the front office to give access to authorized visitors through the front gate. Hong Kingston/Valenzuela is scheduled to be part of the Photovoltaic Project. The first phase will begin in 2013-2014.

More facts about the condition of our school buildings are available in an online supplement to this report called for by the Williams legislation of 2004. What you will find is an assessment of more than a dozen aspects of our buildings: their structural integrity, electrical systems, heating and ventilation systems, and more. The important purpose of this assessment is to determine if our buildings and grounds are safe and in good repair. If anything needs to be repaired, this assessment identifies it and targets a date by which we commit to make those repairs. The guidelines for this assessment were written by the Office of Public School Construction (OPSC) and were brought about by the Williams legislation. You can look at the six-page Facilities Inspection Tool used for the assessment on the Web site of the OPSC.

School Safety Plan

Maxine Hong Kingston School places a strong emphasis on ensuring the safety of all students and staff members. The school's custodial team ensures the school facilities are in compliance with all federal and state health and safety regulations. Each year, a deep cleaning process occurs during the summer or other extended breaks. Site Inspection Checklists are completed quarterly by the Head Custodian and submitted to Risk Management to ensure the physical plant is safe and free from hazards. In the event of a facility plant emergency, the principal notifies appropriate site and district personnel to resolve the emergency and safely secure or evacuate the students, based upon the site and district Readiness and Emergency Management for Schools (REMS). A site review with the district Internal Evaluation Instrument (IEI) occurs annually.

A comprehensive School Safety Plan, which was recently reviewed (December 2014-Final) by the School Site Council, helps to provide a secure, peaceful and clean environment for the school community. The school's REMS Plan identifies procedures to follow during emergencies and natural disasters. Emergency drills (fire drills, secure building drills, and earthquake drills) are conducted on a regular basis. In the event of an emergency or crisis, Parent Link message system and written communication will be used to contact and notify our families and community of the situation and provide updates as needed.

Every effort is made to ensure students are monitored while on campus throughout the school day. The School Safety Team is comprised of the Campus Safety Assistant (CSA), Noon Duty Supervisors, Yard Duty Supervisors, Teachers, and the site administrators. Our School Safety Team provides ongoing supervision during the school day in the main common areas to ensure the campus is safe and orderly for all students. All visitors must sign in at the office and receive proper authorization to be on campus, and must display their passes at all times. To meet Megan's Law requirements, all volunteers have been fingerprinted and cleared by our district's Police Department and passed their TB test.

Professional Development provided for Teachers at Maxine Hong Kingston Elementary

The primary staff development focus was on the Common Core State Standards (CCSS) Units of Study developed by SUSD teachers through the Rigorous Curriculum Design Process. The content was selected due to the full implementation of the CCSS in California in 2014-2015 and the related CAASP state assessment to be implemented in spring of 2015.

Professional development in the core standards and units of instruction was initially provided through full day off site professional development training sessions. Two full day sessions were provided in 2013-2014 and two are planned for 2014-2015. Additionally, onsite coaching is provided.

On-going teacher support is provided through site-based ELA and Math coaches, staff PLC collaboration meetings, data team meetings.
