School Facility Conditions and Planned Improvements (Most Recent Year)

Our school site has classrooms, a multipurpose room, a library and an administration building. We have several portable class rooms to accommodate increased enrollment. The custodial team does a great job at keeping the grounds clean and well manicured. Classrooms, buildings and restrooms are cleaned daily.

District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

A scheduled maintenance program is administered by the district to ensure that all classrooms, restrooms, and facilities are well-maintained and in good repair. The principal works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Stockton Unified takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, we utilize the facility survey instrument developed by the State of California OPSC. The full report is available upon request.

School Safety Plan

Our school places a strong emphasis on ensuring the safety of all students and staff members. The school’s custodial team ensures the school facilities are in compliance with all federal and state health and safety regulations. Each year a deep cleaning process occurs during a close of school, either during the summer or other extended breaks. In the event of a facility plant emergency, the principal notifies appropriate site and district personnel to resolve the emergency and safely secure or evacuate the students, based upon the site and district emergency preparedness plans. A site review with the districts Readiness and Emergency Management Plan (REMS) occurs at the beginning of each year.

A comprehensive School Safety Plan is revised at the beginning of each school year . The plan helps to provide a secure, peaceful and clean environment for the school community. The school’s Readiness and Emergency Management Plan identifies procedures to follow during emergencies and natural disasters. Ongoing teacher training takes place on site for several different disastrous scenarios. Emergency drills are conducted on a regular basis.

Every effort is made to ensure students are monitored while on campus throughout the school day. A Campus Safety Assistant, yard supervisors, teachers, site administrators and school staff provide supervision for students before and during school. The playground is safe for all students. All visitors must sign in at the office and receive proper authorization to be on campus, and must display their passes at all times.

Professional Development provided for Teachers

AVID Strategies are key to improving student achievement. In 2016-2017 AVID strategies were implemented school wide -K-8th grade. A school wide AVID Matrix was put in place to help monitor progression. There are monthly Action walks (which includes a different team of teachers each month), following the action walk the AVID site team meets monthly to create an agreed upon system of expectations for all at Fillmore. Professional development is offered through District AVID program, County , and other AVID conferences. Continuous coaching from the AVID coordinator, individual monitoring, and school-wide monitoring help support teachers

Professional Learning Communities (PLC's) are an integral part of Fillmore's Data Analysis and Action Plans. Collaboration takes place at all grade levels - three times a month. Each grade level sets SMART Goals and adjusts their instruction based on Common Formative Assessments and discussions with their team member.s. Professional development has been provided through Solution Tree on our campus, as well as the staff attending Solution Tree Conferences. Continuous data analysis, admin support and professional development help strengthen our PLC's.
