School Facility Conditions and Planned Improvements (Most Recent Year)

Our facilities are in excellent condition. We have two instructional labs for technology. We have improved the line-up area at our portable buildings, which will improve supervision. We have a comprehensive disaster plan and a well-rehearsed fire drill line-up system.

A new security system includes strategically placed cameras, and an alarm system protects our extensive onsite technology and classroom buildings. All playground equipment meets new state safety standards.

More facts about the condition of our school buildings are available in an online supplement to this report called for by the Williams legislation of 2004. What you will find is an assessment of more than a dozen aspects of our buildings: their structural integrity, electrical systems, heating and ventilation systems, and more. The important purpose of this assessment is to determine if our buildings and grounds are safe and in good repair. If anything needs to be repaired, this assessment identifies it and targets a date by which we commit to make those repairs. The guidelines for this assessment were written by the Office of Public School Construction (OPSC) and were brought about by the Williams legislation. Parents serve on many important committees. New volunteers are always welcome! Our School Site Council approves our school's site plan and budget expenditures. Parents on our English Language Advisory Committee help staff make decisions that affect English Learners. Our parent organizations, the PTA, and the Foothill Kids Foundation have helped us provide new computers for our labs, projectors for our teachers, books that correspond to various student reading levels, the Art Masters program, Accelerated Reader computerized comprehension tests, and many incentives for our student recognition program. They have also purchased tables, umbrellas, and library books.

School Safety Plan

District-approved safety guidelines are integrated into our school's discipline and character education plans. District maintenance and custodial staff inspect equipment regularly, and staff members supervise the playgrounds at recess.

- * Expand intervention programs for at-risk students to prepare them for "a-g" courses.
- * Expand Advancement Via Individual Determination (AVID).
- * Increase the number of "a-g" approved courses and Advanced Placement/International Baccalaureate courses.
- * Expand Counseling Services.
- * Provide parent education regarding course pathways, graduation requirements, post-secondary opportunities, current academic standards; support parent participation and involvement in parent and advisory groups.

DataQuest

DataQuest is an online data tool located on the CDE DataQuest Web page at <http://dq.cde.ca.gov/dataquest/> that contains additional information about this school and comparisons of the school to the district, the county, and the state. Specifically, DataQuest is a dynamic system that provides reports for accountability (e.g., test data, enrollment, high school graduates, dropouts, course enrollments, staffing, and data regarding English learners).

Internet Access

Internet access is available at public libraries and other locations that are publicly accessible (e.g., the California State Library). Access to the Internet at libraries and public locations is generally provided on a first-come, first-served basis. Other use restrictions may include the hours of operation, the length of time that a workstation may be used (depending on availability), the types of software programs available on a workstation, and the ability to print documents.
