### School Facility Conditions and Planned Improvements (Most Recent Year)

Overall our facilities are well maintained and in good condition. Improvements in previous years included refurbished classrooms and a new parking lot and playground equipment. The main building includes 16 classrooms. The center of the main building is the new library and multi-purpose room. We have nine portable classrooms around the playground. Students eat outside at shaded tables; a small kitchen is adjacent. Our office and work areas sit off the breezeway entrance to the school.

More facts about the condition of our school buildings are available in an online supplement to this report called for by the Williams legislation of 2004. What you will find is an assessment of more than a dozen aspects of our buildings: their structural integrity, electrical systems, heating and ventilation systems, and more. The important purpose of this assessment is to determine if our buildings and grounds are safe and in good repair. If anything needs to be repaired, this assessment identifies it and targets a date by which we commit to make those repairs. The guidelines for this assessment were written by the Office of Public School Construction (OPSC) and were brought about by the Williams legislation. - \* Provide parent education regarding course pathways, graduation requirements, post-secondary opportunities, current academic standards; support parent participation and involvement in parent and advisory groups.
