### School Facility Conditions and Planned Improvements (Most Recent Year)

Valencia Elementary opened in 1969 and was modernized during the 2001–2002 school year. We upgraded student and staff restrooms, installed new carpeting, and reconfigured the staff lounge and workroom. The site has permanent and portable structures configured to provide traditional classroom settings, a multipurpose room, a library and media center, a food-service area, administrative offices, and extensive athletic fields. PTA support has enabled us to purchase a new shade cover for the lunch area and new playground equipment. Measure B funds provided an additional shade structure for our kindergarten play area; upgraded fields and perimeter fencing, the new multiuse building, and portable buildings; and improved drainage as well as entrances and exits for the public and emergency personnel.

More facts about the condition of our school buildings are available in an online supplement to this report called for by the Williams legislation of 2004. What you will find is an assessment of more than a dozen aspects of our buildings: their structural integrity, electrical systems, heating and ventilation systems, and more. The important purpose of this assessment is to determine if our buildings and grounds are safe and in good repair. If anything needs to be repaired, this assessment identifies it and targets a date by which we commit to make those repairs. The guidelines for this assessment were written by the Office of Public School Construction (OPSC) and were brought about by the Williams legislation. You can look at the six-page Facilities Inspection Tool used for the assessment on the Web site of the OPSC.

### Opportunities for Parental Involvement (School Year 2017-18)

Parents are active participants at Valencia. Parent Teacher Association (PTA) members contribute volunteer hours working in classrooms, participating on field trips with students, and helping to organize extra-curricular activities. The group raises money to support science and engineering programs, visual and performing arts programs, updating instructional classroom technology, the library collection, and health and safety supplies. Our School Site Council (SSC) is the primary governing body that approves the Single Plan for Student Achievement. Our English Language Advisory Committee (ELAC) also meets to address the educational needs and issues related to our second language learners and families. All parents are invited to attend Coffee with the Principal approximately every six weeks to discuss timely issues, ask questions, and share concerns. All Parents are also invited to attend Parent Information nights offered multiple times throughout the year to learn about instructional programs at Valencia.

### School Safety Plan

We update our District approved School Safety Plan annually and all staff members have assigned duties to perform in case of an emergency. Monthly emergency drills are held so that staff and students are practiced and knowledgeable in procedures for fire, earthquake, and lockdown situations. At least once a year, we hold an extended school-wide major disaster drill.

At Valencia Elementary, we believe that students are safe and supported when they are explicitly taught rules and expected positive behaviors. At the beginning of the year, students rotate through stations throughout the school to learn the expected behaviors for that location (i.e.: bathrooms, playground, hallways, etc.) from our teaching staff. Students are rewarded for exemplary examples of STRIVE behavior. Staff members supervise students before and after school, and paid campus supervisors monitor students during lunch and recesses. Students follow playground safety and game rules through the support of our campus supervisors and Junior Coaches, a program in which our older students learn how to facilitate safe and fair play for their peers. Our students enjoy safe and modern playground equipment. District and school maintenance staff members inspect the equipment and the school campus regularly. All visitors check-in at the office to register upon each visit and are expected to wear Visitor passes while on campus.

- \* Support continued implementation of strategies for Designated and Integrated ELD.
- \* Expand intervention programs for at-risk students to prepare them for "a-g" courses.
- \* Expand Advancement Via Individual Determination (AVID).
- \* Increase the number of "a-g" approved courses and Advanced Placement/International Baccalaureate courses.
- \* Expand Counseling Services.
- \* Provide parent education regarding course pathways, graduation requirements, post-secondary opportunities, current academic standards; support parent participation and involvement in parent and advisory groups.
