School Facility Conditions and Planned Improvements (Most Recent Year)

De Portola Elementary School opened in 1972. The campus was modernized in 2000–2001. A new heating and cooling system was installed and the staff and student bathrooms were remodeled at that time. Overall, the facilities are in excellent condition. In 2004, voters passed a bond measure that enabled us to add a playground structure, multiuse building, storage cabinets in the multipurpose room, field renovations, a security system, field restrooms, and other improvements.

More facts about the condition of our school buildings are available in an online supplement to this report called for by the Williams legislation of 2004. What you will find is an assessment of more than a dozen aspects of our buildings: their structural integrity, electrical systems, heating and ventilation systems, and more. The important purpose of this assessment is to determine if our buildings and grounds are safe and in good repair. If anything needs to be repaired, this assessment identifies it and targets a date by which we commit to make those repairs. The guidelines for this assessment were written by the Office of Public School Construction (OPSC) and were brought about by the Williams legislation. You can look at the six-page Facilities Inspection Tool used for the assessment on the Web site of the OPSC.

Professional Development provided for Teachers

Our school participates in the SVUSD Professional Development programs. Training focuses on core academic subjects as well as the diagnosis and assessment of students' learning needs and the use of technology. Teachers, curriculum specialists, and administrators plan and implement teacher-training activities. Instructional Coach provides on-going support and training in SVUSD initiatives.

Teachers engage in training around the three district priorities: student engagement, innovation and intentional lesson design. Teacher have received extensive training for Benchmark, which is the new ELA/ELD adopted curriculum. Math is also a district focus this year with district opportunities for lesson design and lesson study. Social Studies adoption is in progress and more training will be provided upon completion of the process.
