School Facility Conditions and Planned Improvements (Most Recent Year)

In the 2007–2008 school year, we completed full-scale modernization. Our renovated school facilities include computer pods within grade levels, a computer lab with 35 computers and Internet access, and a library located in the center of the school. We have a covered outdoor lunch area off the kitchen. The Learning Center is also on our campus for childcare.

What you will find is an assessment of more than a dozen aspects of our buildings: their structural integrity, electrical systems, heating and ventilation systems, and more. The important purpose of this assessment is to determine if our buildings and grounds are safe and in good repair. If anything needs to be repaired, this assessment identifies it and targets a date by which we commit to make those repairs. The guidelines for this assessment were written by the Office of Public School Construction (OPSC) and were brought about by the Williams legislation. School Safety Plan

We implement district approved safety plans each year and integrate them into our site discipline and character education plans. With PTA's assistance, we have an earthquake storage area that we restock annually with food, water, and first aid supplies. Our staff meets at the beginning of the school year to discuss procedures for drills and real emergency situations including fire, earthquakes, and situations requiring school-wide lockdowns. Gates and doors on our campus are locked throughout the school day. Visitors are expected to check in at our administrative office before entering our campus and all staff wear identification badges.

Professional Development provided for Teachers

We offer teacher training on staff development days and after school. This year our teachers focused on teaching strategies in reading and mathematics and on using electronic grade books to report grades on the Internet. Teachers meet regularly in grade level teams to review student work, plan instruction, and review teaching strategies.

Teachers engage in training around the three district priorities: student engagement, innovation and intentional lesson design. Teacher have received extensive training for Benchmark, which is the new ELA/ELD adopted curriculum. Math is also a district focus this year with district opportunities for lesson design and lesson study. Social Studies adoption is in progress and more training will be provided upon completion of the process.
