Additionally, we are focused on implementing explicit instruction in behavior and social emotional learning through Positive Behavior Intervention and Support (PBIS) and the concepts within Bucket Filling.

Our staff is focused on providing an engaging environment with innovative lessons that challenge all students to reach their full potential. From the time you walk onto the Montevideo campus, it is easy to feel the sense of community between parents, PTA, staff, and students. Parental involvement is the norm and adds to the warm collaborate atmosphere at the school.

School Facility Conditions and Planned Improvements (Most Recent Year)

Montevideo dates from 1973. The school has permanent and portable structures plus a multipurpose room, a library/media center, a food-service area, administrative offices, and extensive athletic fields. We use two portables for childcare before and after school. Seven portable buildings house supporting programs and are used by our Special Day Classes for extra therapies and play. All class-size averages are within state and district guidelines. Montevideo underwent a partial remodel during the summer of 2007. The full remodel was completed in 2008 and was funded by state and local bond money.

More facts about the condition of our school buildings are available in an online supplement to this report called for by the Williams legislation of 2004. What you will find is an assessment of more than a dozen aspects of our buildings: their structural integrity, electrical systems, heating and ventilation systems, and more. The important purpose of this assessment is to determine if our buildings and grounds are safe and in good repair. If anything needs to be repaired, this assessment identifies it and targets a date by which we commit to make those repairs. The guidelines for this assessment were written by the Office of Public School Construction (OPSC) and were brought about by the Williams legislation. School Safety Plan

Our administration actively promotes a safe environment for all students and staff. We require visitors to sign in at the front office and wear identifying badges. All of our staff wear photo identification for added safety. Teaching staff and campus supervisors monitor playground, campus, and building safety. We train staff annually on our School Safety Protocols and hold monthly safety drills. Staff of Montevideo have been trained on all water, gas, and electric shut off procedures in case of a disaster. Our vision and our core values encourage respect, responsibility, kindness, and school pride. We also participate in the City of Mission Viejo Community of Character program. Students attend a school-rules assembly in the fall, and each family has access to a Student Handbook outlining school, district, and state policies. Our student news program KidsROCK reinforces school knowledge and celebrates Montevideo.

The school's comprehensive safety plan is reviewed each year by the School Site Council with the input of our Safety Resource Officer. The school has implemented practices that the school site remains locked during the school day. The community is informed about safety procedures through the school website, handbook, and newsletters. The staff is taken through a yearly review of safety procedures and offered health training such as EPI-PEN usage each year.

Professional Development provided for Teachers

We collaborate within grade levels and across grade levels in efforts to improve student achievement and instructional practices at our school. The district offers a variety of trainings and resources for teachers to grow professionally and exchange ideas with peers at other sites. Summer seminars are available, and teachers are often released during the school day to attend trainings.

Data Team meetings are regularly held to help inform instruction and ultimately staff development. Instructional Rounds have been introduced and is a process of looking at our classroom practices and how we can improve student achievement through collaboration and agreements on instructional strategies. Teachers engage in training around the three district priorities: student engagement, innovation and intentional lesson design. Teacher have received extensive training for Benchmark, which is the new ELA/ELD adopted curriculum. Math is also a district focus this year with district opportunities for lesson design and lesson study. Social Studies adoption is in progress and more training will be provided upon completion of the process.
