School Description

Olivewood Elementary School is a community of responsible 21st century learners. We use our creativity, collaboration, critical thinking, and communication skills to grow into positive, productive citizens who will succeed in tomorrow's world. We have Mustang P.R.I.D.E. which stands for "Prepared, Respectful, Integrity, Dependable, Engaged."

Classroom teachers grades K-6 implement Common Core State Standards. All students, including grades TK and students in Special Education classes are taught to think about "Why?" an answer is correct and "How" they know it to be true. We support instruction with integrated and designated English Language Development (ELD) for second language learners at all grades, and Advancement Via Individual Determination (AVID) Elementary school-wide. Olivewood also houses the innovative iEngage program, a one-to-one mobile technology program that transforms the way that teachers teach and students learn. Students use iPads in all grade levels, grades 3-6 have Chromebooks one-to-one. Grades TK-6 use technology to work on enhancing their ability to create, innovate, learn in order to be college, career, and life-ready.

About the SARC

School Facility Conditions and Planned Improvements (Most Recent Year)

Olivewood dates from 1967 and was modernized during 2003–2004. This included fresh paint, new wall coverings, additional Internet access, new security and intercom systems, and improved electrical and plumbing systems. New playground equipment has been installed in the kindergarten, primary, and upper-grade playgrounds. The field has been upgraded with a new sprinkler system and new sod; shade structures were installed over the outdoor assembly area and the lunch area. A new building to house a library and two computer labs was opened in May 2008. The parking lot was expanded, and two portable buildings were replaced with newer models.

More facts about the condition of our school buildings are available in an online supplement to this report called for by the Williams legislation of 2004. What you will find is an assessment of more than a dozen aspects of our buildings: their structural integrity, electrical systems, heating and ventilation systems, and more. The important purpose of this assessment is to determine if our buildings and grounds are safe and in good repair. If anything needs to be repaired, this assessment identifies it and targets a date by which we commit to make those repairs. The guidelines for this assessment were written by the Office of Public School Construction (OPSC) and were brought about by the Williams legislation. Professional Development provided for Teachers

Title 1 funding allows time for teachers and administrators to look at test scores and review the most pressing issues of the previous year to choose specific topics for staff development. District-level staff development concentrates on districtwide goals. We devote school staff development days to improving written language and subject area skills. During the school year, all teachers meet in grade-level groups to review students' writing progress, analyze standardized test scores, plan instruction, and review teaching strategies.

Teachers engage in training around the three district priorities: student engagement, innovation and intentional lesson design. Teacher have received extensive training for Benchmark, which is the new ELA/ELD adopted curriculum. Math is also a district focus this year with district opportunities for lesson design and lesson study. Social Studies adoption is in progress and more training will be provided upon completion of the process.
