School Facility Conditions and Planned Improvements (Most Recent Year)

Trabuco was built in 1879 and is the oldest school in Orange County. We have updated and replaced buildings to create a site that supports Internet access and houses the Trabuco Field Study Program. In addition to well maintained classrooms, our site includes a corral and stables in keeping with community tradition. Our updated playground features safe and accessible play equipment. Funds from Measure B have allowed us to complete modifications and improvements to classrooms and student restrooms.

More facts about the condition of our school buildings are available in an online supplement to this report called for by the Williams legislation of 2004. What you will find is an assessment of more than a dozen aspects of our buildings: their structural integrity, electrical systems, heating and ventilation systems, and more. The important purpose of this assessment is to determine if our buildings and grounds are safe and in good repair. If anything needs to be repaired, this assessment identifies it and targets a date by which we commit to make those repairs. The guidelines for this assessment were written by the Office of Public School Construction (OPSC) and were brought about by the Williams legislation. Professional Development provided for Teachers

The major area of focus for staff development is on student and teacher accountability through the data team and instructional rounds processes. These processes inform instructional decisions with an emphasis on the effective use of materials for core curriculum areas and a review of student progress using student engagement strategies and common assessments. During the 2016-2017 school year, Trabuco Elementary's primary areas of focus was on using reasoning and evidence in mathematics and integration of technology to enhance student outcomes in all academic disciplines. For the 2017-2018 school year, Trabuco teachers focused on problem-based learning in science, while maintaining their focus on mathematics instruction. This 2018-2019 school year, Trabuco teachers will maintain their mathematics problem-solving focus with an emphasis on discourse. Great attention will be given to the importance of collaboration around formative assessment data. Teachers will participate in professional development delivered by the district, attending after school workshops and conferences and through lesson studies conducted on campus. Teachers will be supported by teacher-principal observation and follow-up meetings, student performance data meetings, and professional development by the principal, district, and outside sources.
